RELEASE & WAIVER OF LIABILITY

In consideration of Grace Heritage Ranch, LLC ("GHR") allowing me or my child to participate in certain Agritourism Activities and Farm Animal Activities (as defined in Tex. Civ. Prac. & Rem. Code §§ 75A.001 and 87.001) (together the "Activities") at Grace Heritage Ranch (the "Ranch"), I hereby agree as follows:

A. Acknowledgement of Risks

- 1. I fully understand and hereby acknowledge that the Activities have inherent risks, dangers and hazards.
- 2. My own or my child's participation in the Activities may result in injury, illness or death.

B. Assumption of Risks

I will obey the GHR staff in regards to those rules as they affect the safety of myself, other participants and observers, the property of GHR, and all animals and/or natural resources used in conjunction with the Activities.
- **E.** Release from Liability. I, on behalf of myself, my child, my personal representatives, my equipment, my heirs and assigns, hereby voluntarily waive, release, discharge, hold harmless, defend and indemnify GHR, its agents, employees, officers, managers, and members from any and all claims, actions, losses for bodily injury, property damage, wrongful death, loss of services, or otherwise, which may arise from my own or my child's participation in the Activities at the Ranch regardless of any negligent acts or omissions of GHR, its agents, officers, or employees.
- **F. Venue.** The venue for any dispute arising out of this agreement shall be Hidalgo County, Texas.
- **G. Consent to Use of Image.** I hereby authorize GHR to publish photographs or video recordings of myself and my child for use in GHR's print, online, and video-based marketing materials.
